HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB23-1061 be amended as follows:

1 Amend printed bill, page 2, line 4, strike "A" and substitute "EXCEPT AS
2 PROVIDED IN SUBSECTION (1)(c) OF THIS SECTION, A".

3 Page 2, line 14, strike "and" and substitute "and".

4 Page 3, strike line 1 and substitute "days per year; ~~of licensure~~."

5 (IV) SERVE MALT LIQUOR OR VINOUS LIQUOR OF A SERVING SIZE
6 OF MORE THAN TWELVE OUNCES;

7 (V) SERVE SPIRITUOUS LIQUOR OF A SERVING SIZE OF MORE THAN
8 SIX OUNCES;

9 (VI) HOLD ANY OTHER LICENSE ISSUED UNDER THIS PART 4 TO
10 SELL OR SERVE ALCOHOL BEVERAGES;

11 (VII) SERVE OR DISTRIBUTE ALCOHOL BEVERAGES BETWEEN 2 A.M.
12 AND 7 A.M.;

13 (VIII) PERMIT A PERSON UNDER EIGHTEEN YEARS OF AGE TO SELL,
14 DISPENSE, OR PARTICIPATE IN THE SALE OR DISPENSING OF AN ALCOHOL
15 BEVERAGE; OR

16 (IX) PERMIT A PERSON EIGHTEEN YEARS OF AGE OR OLDER AND
17 UNDER TWENTY-ONE YEARS OF AGE TO SELL, DISPENSE, OR PARTICIPATE
18 IN THE SALE OR DISPENSING OF AN ALCOHOL BEVERAGE, UNLESS THE
19 PERSON IS SUPERVISED BY ANOTHER PERSON WHO IS ON THE PERMITTED
20 PREMISES AND IS AT LEAST TWENTY-ONE YEARS OF AGE.

21 (c) (I) THIS SECTION APPLIES TO A RETAIL ESTABLISHMENT THAT
22 IS AN ART GALLERY OR ANY OTHER RETAIL ESTABLISHMENT, EXCEPT
23 RETAIL ESTABLISHMENTS DESCRIBED IN SUBSECTION (1)(c)(II) OF THIS
24 SECTION, THAT:

25 (A) HAS NO MORE THAN TWENTY-FIVE EMPLOYEES; AND

26 (B) HAS RETAIL SALES OF NO MORE THAN FIVE MILLION DOLLARS
27 PER YEAR.

28 (II) THIS SECTION DOES NOT APPLY TO A RETAIL ESTABLISHMENT
29 THAT:

30 (A) SELLS FIREARMS, MOTOR VEHICLES, MARIJUANA, GASOLINE,
31 OR DIESEL FUEL;

32 (B) EDUCATES STUDENTS FROM KINDERGARTEN TO TWELFTH
33 GRADE OR PROVIDES CHILD CARE; OR

34 (C) IS A CONVENIENCE STORE."

35 Page 6, line 2, strike "one" and substitute "one TWO".
